1982	9/07	3 rd set of regalia/2 nd headdress purchased	 The Marching Illini announced that Chief Illiniwek would begin using the new regalia This set included: tunic, leggings, moccasins, breastplate, and a headdress with 28 golden eagle tail feathers This headdress had no "trail" (i.e., it was a short bonnet-style headdress), so it was never used by Chief Illiniwek A separate document referenced a blanket (which was a personal gift from Mrs. Fools Crow to Mrs. Smith) and peace pipe that Mr. Fools Crow brought to use in a presentation ceremony
1982	9/16		A letter was written to correct a mistake in the 1982 football guide, which said the regalia had been a gift from a Sioux chief, when it had actually been purchased for \$3,500
1983	7/25		Mr. Leutwiler said in a letter that he was donating the original set of regalia to the University and that a dedication ceremony would be held homecoming weekend
1987	8/11		President Stanley Ikenberry sent a letter to the Oglala Sioux Council asking that someone complete the effort to rework the Fools Crow bonnet-style headdress with 25 loose feathers to create the desired trail
1990	10/05		Alumni Association was in possession of at least one so-called "roach" headdress that contained two turkey feathers (likely one from Mr. Leutwiler's personal collection)
1990	10/05	3 rd and 4 th headdresses purchased	Two new headdresses were created by Roy Hanks of Tolono, and were described as containing: Tail feathers of a white domestic turkey Wing feathers of a white domestic turkey

1991	5/23		Judy Rowan of Public Affairs sent a letter to the Department of Fish and Wildlife stating that 25 eagle feathers that had once been in the possession of the University had since been returned to Chief Fools Crow and that a headdress had been given to Anthony Whirlwind Horse; the note refers to one pre-1940 headdress still in the University's possession

1992			Bill Hayes sewed a new set of gloves

1993	1/05		The only remaining headdress with eagle feathers was from 1930 (which was grandfathered in under the restrictions on possession of eagle feathers); the two Leutwiler headdresses were returned to Mr. Leutwiler
